- This circumstance will be communicate by Sunday 22 at 12am through PlanX Instagram profile (@PlanXartGallery) website (www.planxartgallery.com) and by email to all the bidders;
- **The entire profits will be donated to Hospitals Luigi Sacco in Milan and Domenico Cotugno in Naples** (50% each) to fight the Covid-19 crisis;
- To be able to take part at the auction, all participants must register on PlanX Art Gallery website (www.planxartgallery.com);
- All the transactions will be via PayPal; all the bidders can connect their PayPal account to their credit card or directly to their bank account;
- Package and shipping expenses will be covered by the final buyers;
- All the prices are excluded VAT and importation taxes;
- Due to covid-19 crisis, expected delays on shipments may occur;
- The "BUY NOW" button placed under each artwork gives every bidder the possibility to become "BIG DONOR"
